General disagreement may concern immunity in criminal law (*e.g.*, the employment of robot soldiers in battle), personal accountability for certain robots in contracts (*e.g.*, robo-traders), much as clauses of strict liability and negligence-based responsibility in extra-contractual obligations (*e.g.*, service robots in tort law). Since robots are here to stay, the aim of the law should be to wisely govern our mutual relationships.
